

Scale and Scope of Activity: Proposed Development and Operation of a Bulk Refined Fuel Storage Facility in NamPort North Port Industrial Area, Walvis Bay, Erongo Region, Namibia will cover the following activities:

- (i) Permitting and preconstruction activities may be required.
- (ii) Construction of the proposed bulk refined fuel storage facility infrastructure.
- (iii) Operation, ongoing monitoring and rehabilitation of the proposed bulk refined fuel storage facility and.
- (iv) Decommissioning, closure and aftercare of the site.

The construction of proposed bulk refined fuel storage facility facilities on the portion of land falling on Farm 39, NamPort North Port within the Walvis Bay municipal area will have insignificant impacts on the local receiving environment with extremely unlikely probability of occurrence without mitigations. Overall significant impacts will be negligible except for the socioeconomic components which will be low to medium positive impacts. The proposed development area falls within NamPort, North Port area is already disturbed with existing and planned new infrastructure and the surrounding areas are also not pristine. Based on the findings of this EIA and EMP Report, it is hereby recommended that the leased land to be used for proposed bulk refined fuel storage facility facilities be issued with an ECC with key conditions of adhering to all the provisions of the EMP and requirements and conditions of the Lease Agreement and all applicable national regulations, municipal by-laws and NamPort standards and requirements. Mitigation measures shall be implemented as detailed in Section 6 (EMP) of the attached EIA and EMP Report.

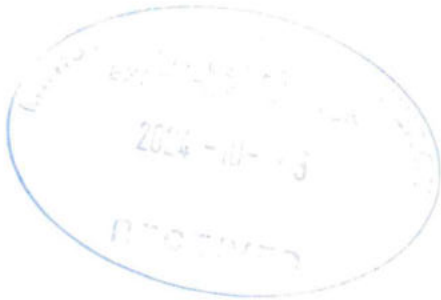

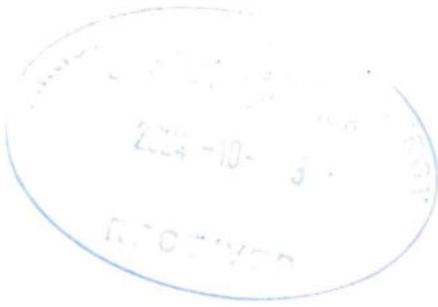
