#### 1 INTRODUCTION

The Oranjemund Town Council hereinafter referred to as the proponent intends to undertake the following activities:

- Subdivision of Erf 2129, Oranjemund Extension 3 into Erf A and Remainder;
- Rezoning of Erf A (a portion of Erf 2129, Oranjemund Extension 3) from "General Residential" to "Office" with a bulk of 1.5.

An Environmental Management Plan (EMP) is one of the most important outputs of the EIA process as it synthesises all the proposed mitigation and monitoring actions, set to a timeline and with specific assigned responsibilities. This EMP details the mitigation and monitoring actions to be implemented during the following phases of these developments:

- <u>Planning and Design</u> the period, prior to construction, during which preliminary legislative
  and administrative arrangements, necessary for the preparation of the development, are
  made and engineering designs are carried out. The preparation of construction tender
  documents forms part of this phase;
- <u>Construction</u> the period during which the proponent, having dealt with the necessary legislative and administrative arrangements, appoints a contractor for the construction of the proposed development as well as any other construction process(s) within the development areas;
- Operation and Maintenance the period during which the services infrastructure will be fully functional and maintained.

The decommissioning of these developments is not envisaged; however in the event that this should be considered some recommendations have been outlined in **Table 4-5**.

#### 2 PROPOSED DEVELOPMENT

#### 2.1 LOCALITY

As depicted in **Figure 2-2** below, Erf A (a portion of Erf 2129 Oranjemund Extension 3) is located west of the Oranjemund Stadium, south of the Rhino Court and is in close proximity to the Oranjemund Cricket Club. The subject erf is situated in the neighbourhood of Oranjemund Extension 3, along Twelfth Street. The subject portion measures approximately **646m²** in extent.

## 2.2 LAND USE

In terms of the Oranjemund Zoning Scheme, Erf A (a portion of Erf 2129 Oranjemund Extension 3) is zoned for "General Residential" purposes. Erf A (a portion of Erf 2129 Oranjemund Extension 3) is to be rezoned from "General Residential" to "Office" with a bulk of 1.5, as shown in **Figure 2-5.** The proposed Erf currently accommodates government offices. The erf is surrounded by "General Residential", "Office", "Local Authority" erven, and an "Institutional" erf.

#### 2.3 OWNERSHIP

According to the Deeds of Transfer No. T5301/2015 ownership of Erf 2129, Oranjemund Extension 3 from which Erf A (a portion of Erf 2129, Oranjemund Extension 3) is subdivided vests with the Oranjemund Town Council.




Figure 2-1: Locality map of Erf 2129, Oranjemund Extension 3




Figure 2-2: Locality map of Erf A (a portion of Erf 2129, Oranjemund Extension 3

As part of the town's transformation plan, the Oranjemund Town Council and NAMDEB signed an agreement for the transfer of some of the services, infrastructure and assets to the Oranjemund Town Council, Government and Private individuals. It is, NAMDEB's intention to subdivide Erf 2129, Oranjemund Extension 3 into Erf A and Remainder and in so doing, transferring ownership of Erf A/2129 to the Government Republic of Namibia. Erf A (a portion of Erf 2129, Oranjemund Extension 3) currently accommodates government offices and is zoned for "General Residential" purposes.

However, the transferring of proposed Erf A (a portion of Erf 2129, Oranjemund Extension 3) from NAMDEB to the Government of the Republic of Namibia is only possible once the proposed Erf A/2129 on which the government offices are located is rezoned to "office" thus aligning the land uses on Erf A/2129 with the right zoning. The current zoning designation of Erf A (a portion of Erf 2129, Oranjemund Extension 3), as "General Residential" does not align with the desired long term office use. Therefore, it is the proponent' intention to undertake the following activities:

- Subdivision of Erf 2129, Oranjemund Extension 3 into Erf A and Remainder;
- Rezoning of Erf A (a portion of Erf 2129, Oranjemund Extension 3) from "General Residential" to "Office" with a bulk of 1.5.

### 2.3.1 Subdivision of Erf 2129, Oranjemund Extension 3.

The proponent proposes the subdivision of Erf 2129, Oranjemund Extension 3 into Erf A and Remainder as seen in Figure 3. The subdivision of Erf 2129, Oranjemund Extension 3 into Erf A and the Remainder will facilitate the transfer of Erf A, which contains government offices, to the Government of Namibia.

# 2.3.2 Rezoning Erf A (a portion of Erf 2129, Oranjemund Extension 3) from "General Residential" to "Office" with a bulk of 1.5.

In addition, the proponent intends to rezone Erf A (a portion of Erf 2129, Oranjemund Extension 3) from "General Residential" to "Office" with a bulk of 1.5 as seen in Figure 5, which is required for the transfer of proposed Erf A (a portion of Erf 2129, Oranjemund Extension 3) from NAMDEB to the Government of the Republic of Namibia which is only possible once the proposed Erf A/2129 on which the government offices are located is rezoned to "office" thus aligning the land uses on Erf A/2129 with the right zoning.

By rectifying this discrepancy and rezoning the property as an office zone, Council ensures that the use of the erf aligns with the intended purpose. This rectification will bring the property into

compliance with Council's zoning regulations, providing clarity and consistency for future development and land use planning.

The proposed rezoning of Erf A (a portion of Erf 2129, Oranjemund Extension 3) will be done in accordance with the Oranjemund Zoning Scheme as outlined in **Table 2-1** below, which is extracted from **Table B** of the Oranjemund Zoning Scheme.




Figure 2-3: Subdivision of Erf 2129, Oranjemund Extension 3 into Erf A and Remainder.




Figure 2-4: Aerial photo of proposed Erf A (a portion of Erf 2129 Oranjemund Extension 3)




Figure 2-5: Rezoning Erf A (a portion of Erf 2129, Oranjemund Extension 3) from "General Residential" to "Office" with a bulk of 1.5.




Figure 2-6: Surrounding Land Use Map of Erf A (a portion of Erf 2129), Oranjemund Extension 3.

#### 3 ROLES AND RESPONSIBILITIES

The proponent is ultimately responsible for the implementation of the EMP, from the planning and design phase to the decommissioning phase (if these developments are in future decommissioned) of these developments. The proponent will delegate this responsibility as the project progresses through its life cycle. The delegated responsibility for the effective implementation of this EMP will rest on the following key individuals:

- Proponent's Representative;
- Environmental Control Officer; and
- Contractor (Construction and Operations and Maintenance).

## 3.1 PROPONENT'S REPRESENTATIVE

The proponent should assign the responsibility of managing all aspects of these developments for all development phases (including all contracts for work outsourced) to a designated member of staff, referred to in this EMP as the Proponent's representative (PR). The proponent may decide to assign this role to one person for the full duration of these developments or may assign a different PR to each of the development phases – i.e. one for the planning and design phase, one for the construction phase and one for the operation and maintenance phase. The PR's responsibilities are as follows:

#### 3.2 ENVIRONMENTAL CONTROL OFFICER

The proponent should assign the responsibility of overseeing the implementation of the whole EMP on the ground during the construction and operation and maintenance phases to an independent and suitably qualified external consultant, referred to in this EMP as the Environmental Control Officer (ECO). The proponent may decide to assign this role to one person for both phases, or may assign a different ECO for each phase. The ECO will have the following responsibilities during the construction and operation and maintenance phases of these developments:

- Management and facilitation of communication between the proponent, PR, the contractors, and Interested and Affected Parties (I&APs) with regard to this EMP;
- Conducting bi-annual site inspections and auditing all construction and/or infrastructure maintenance areas with respect to the implementation of this EMP (audit the implementation of the EMP);
- Assisting the Contractor in finding solutions with respect to matters pertaining to the implementation of this EMP;
- Advising the PR on the removal of person(s) and/or equipment not complying with the provisions of this EMP;
- Making recommendations to the PR with respect to the issuing of fines for contraventions of the EMP; and
- Undertaking an annual review and bi-annual audit of the EMP and recommending additions and/or changes to this document.

## 3.3 CONTRACTOR

Contractors appointed by the proponent are automatically responsible for implementing all provisions contained within the relevant chapters of this EMP. Contractors will be responsible for the implementation of this EMP applicable to any work outsourced to subcontractors. **Table 4-3** applies to contractors appointed during the construction phase and **Table 4-4** to those appointed during the operation and maintenance phase. In order to ensure effective environmental management, the aforementioned chapters should be included in the applicable contracts for outsourced construction, operation and maintenance work.

The tables in the following chapter (**Chapter 4**) detail the management measures associated with the roles and responsibilities that have been laid out in this chapter.

#### 4 MANAGEMENT ACTIONS

The aim of the management actions in this chapter of the EMP is to avoid potential impacts where possible. Where impacts cannot be avoided, measures are provided to reduce the significance of these impacts.

The following tables provide the management actions recommended to manage the potential impacts rated in the scoping-level EA conducted for these developments. These management actions have been organised temporally according to project phase:

- Applicable legislation (Table 4-1);
- Planning and design phase management actions (Table 4-2);
- Construction phase management actions (Table 4-3);
- Operation and maintenance phase management actions (Table 4-4); and
- Decommissioning phase management actions (Table 4-5).

The proponent should assess these **commitments** in detail and should acknowledge their commitment to the specific management actions detailed in the tables below.

## 4.1 ASSUMPTIONS AND LIMITATIONS

This EMP has been drafted with the acknowledgment of the following assumptions and limitations:

- This EMP has been drafted based on the scoping-level Environmental Assessment (EA) conducted for the proposed development. SPC will not be held responsible for the potential consequences that may result from any alterations to the abovementioned layout.
- It is assumed that construction labourers will be sourced mostly from the Oranjemund townlands area and that migrant labourers (if applicable) will be housed in established accommodation facilities within Oranjemund.
- No engineering designs have been carried out for the development of the associated services infrastructure (roads, potable water, storm water, sewerage and electrical reticulations).
