Matt has over 10 years experience in the oil & gas sector. As a university student, he completed multiple oil & gas summer geology internships, including two with the Oklahoma Geological Survey's Oklahoma Petroleum Information Center (OPIC) in Norman, Oklahoma (2004 & 2005), two with Dominion E&P in Oklahoma City, Oklahoma (2006 & 2007), and one with BP's Western Gulf of Mexico (GoM) Exploration Team (deepwater Paleogene prospecting) in Houston, Texas (2010).

After earning a B.S. 


