Samison Mulonga is an environmental and conservation professional. Samison's career has focussed mainly on natural resource management beginning with a research project on community based natural resource management. Since then, he has moved on to positions of Junior Researcher at the University of Namibia before joining the United Nations Development Programme and Global Environment Facility funded Project: Strengthening the Protected Areas Network (SPAN) Project of the Ministry of Environment and Tourism (MET). Samison worked as Programme Officer for Environment and Sustainable Development at the Southern African Development Community Secretariat in Gaborone, Botswana. Samison has conducted more than 20 Environmental Impact Assessments and developed accompanying Environmental Management Plans. Samison has also undertaken environmental monitoring for project and compiled monitoring reports for submission to MEFT-DEA. He recently developed the SESA for the Human Wildlife Conflict-Wildlife Crime Project for the North-eastern Hotspot Landscape.
