MINUTES OF THE MEETING FOR RENEWAL OF THE ENVIRONMENTAL CLEARANCE CERTIFICATE AT ONHOKOLO BURROW PIT

The community sensitisation meeting on the procedures of the application for the renewal of the sand mining Environmental Clearance Certificate for Onhokolo burrow pit was held on 12 February 2022 at the Burrow Pit.

AGENDA ITEMS

1. **The opening prayer was done by Mrs. Hileni Muzanima a Village Committee member**
2. **Welcoming Remarks**

The welcoming remark was done by the Village headman, Tk. Paulus Shiluwa who has welcomed all the members and thanked them for their attendance and urged them to participate and contribute fully to the discussions.

3. Discussion

During the discussions the following procedures have been explained to the Community.

- a. The Traditional Authority (TA) representatives have been explaining to the Village Community members the procedures of applying for the sand mining Environmental Clearance Certificate, in terms of the Environmental Management Act 7 of 2007.
- b. Methods and procedures of sand mining, which includes step one to five (1-5) instructions from the Department of Environmental Affairs.
- c. Section 17 (1) and Regulations 33 (4) of the Communal Land Reform Act 5 of 2002
- d. The sand mining procedures and the distribution of the levy accrued from the sand mining activities, which is to be distributed as follows:
 - i. Village Community (Ward) Account 35% from each load extracted.
 - ii. Village representative 10% from each load extracted.
 - iii. The Traditional Authority Community Trust Fund Account 35% from each load extracted.

- iv. The Traditional Authority representative at the burrow pit 10% from each load extracted.
- v. Pit rehabilitation account 10% from each load extracted.

The Village headman Tk. Paulus Shiluwa thanked the Village Community members for attending the meeting and for their meaningfully contribution the discussions.


6. Closing remarks
