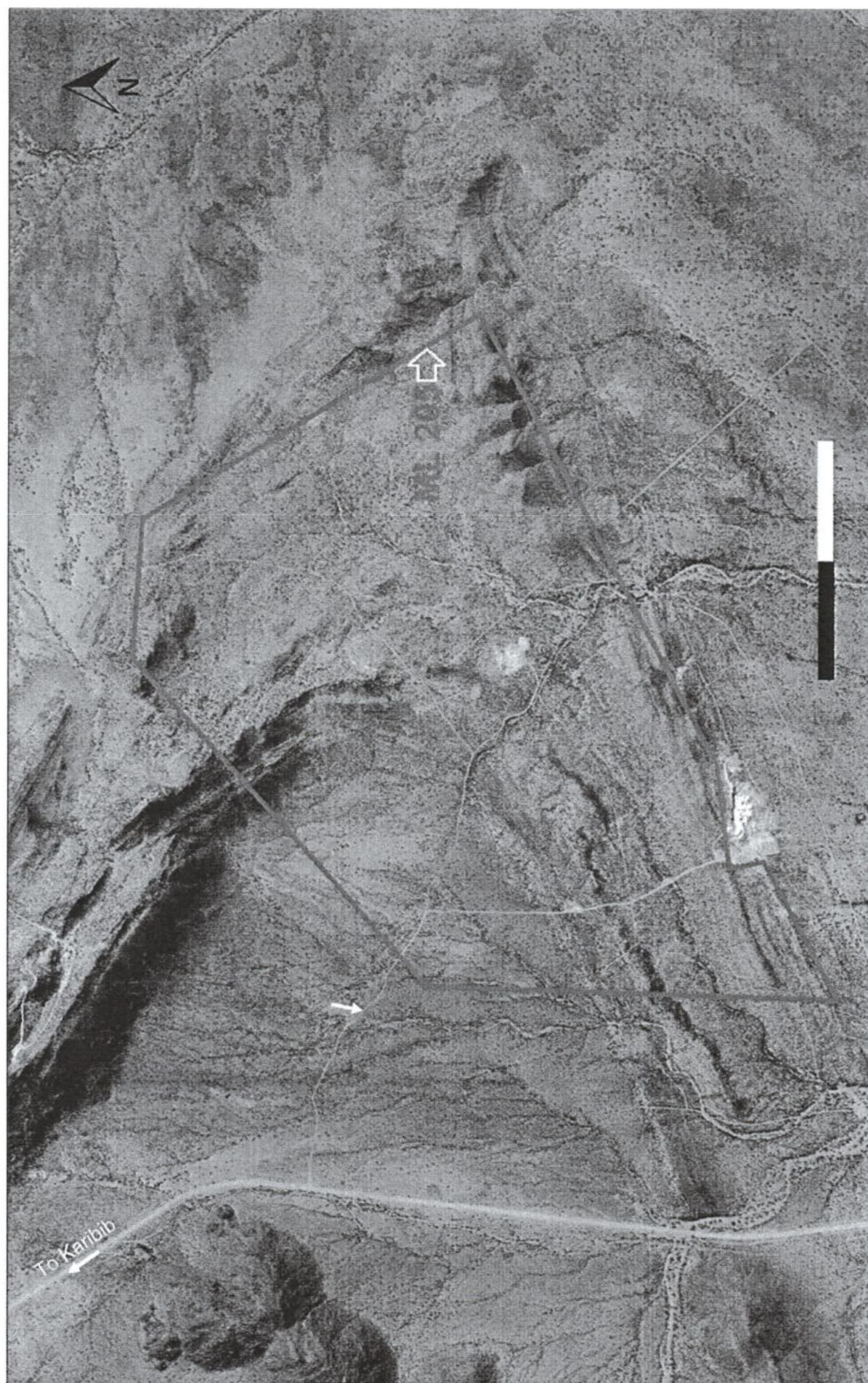


Figure 1: Location of ML 205
