Thank you so much for your email and comments. I have captured them from our WhatsApp interaction as well. They are great comments and really forms basis for engagement, which is the reason for having stakeholder meetings. 3. On the constituent of the company Board, we are limited to comment on their execution of functions
4. 'Speculation' The company pegs EPLs based on scientific data from various geological material. They then need to carry out exploration to figure out if there is sufficient mineral for mining. This process is universal in all mineral exploration and consequent mining.
5.
