TITLE OF ACTIVITY:

Proposed Exploration Well Drilling in PEL 82 covering Blocks 2112B and 2212A, Walvis Basin, off the Coast of Southern Namibia

NATURE OF ACTIVITY:

A proposed offshore exploration program that will utilize a drilling unit (drillship) to drill up to five (5) exploration wells and five (5) appraisal wells.

LOCATION OF ACTIVITY:

PEL 82 license (includes Blocks 2112B and 2212A) covering an area of approximately 11,400 square kilometers located between 80 and 300 kilometers from the Namibian coastline with water depths ranging from 200 - 2500 meters. The initial activity is proposed for the Mataku prospect in 1000-1500 meters water depth and will take approximately 2-3 months.


SCALE AND SCOPE OF ACTIVITY:

The Project Scope may include:

1. Up to five (5) Exploration Wells in to-be-determined locations, by drilling, deepening or sidetracking, and testing and completing the wells and,
2. Up to five (5) Appraisal Wells, whether by drilling, deepening or sidetracking, and testing and completing such Appraisal Wells,
3. Vertical Seismic Profiling (VSP),
4. Well testing, and
5. Plugging and abandonment of wells offshore.
