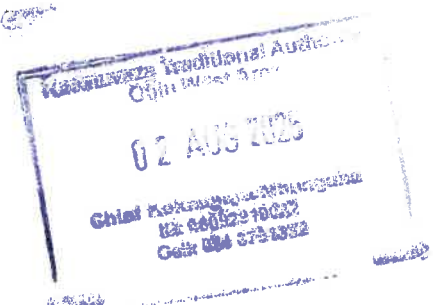
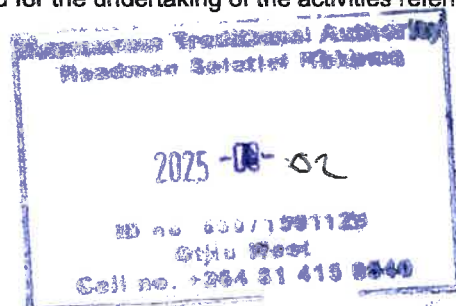

 - 5.3. drilling boreholes and/or extracting water from available sources in the vicinity of EPL 10738 as may be required for the undertaking of the activities referred to in paragraphs 5.1, 5.2 and 5.4;

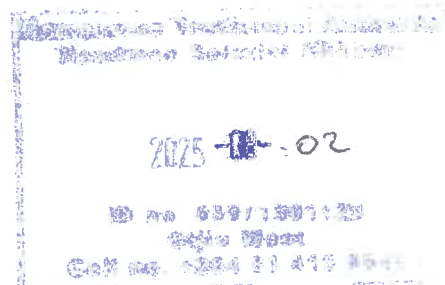
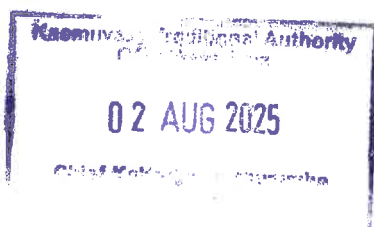

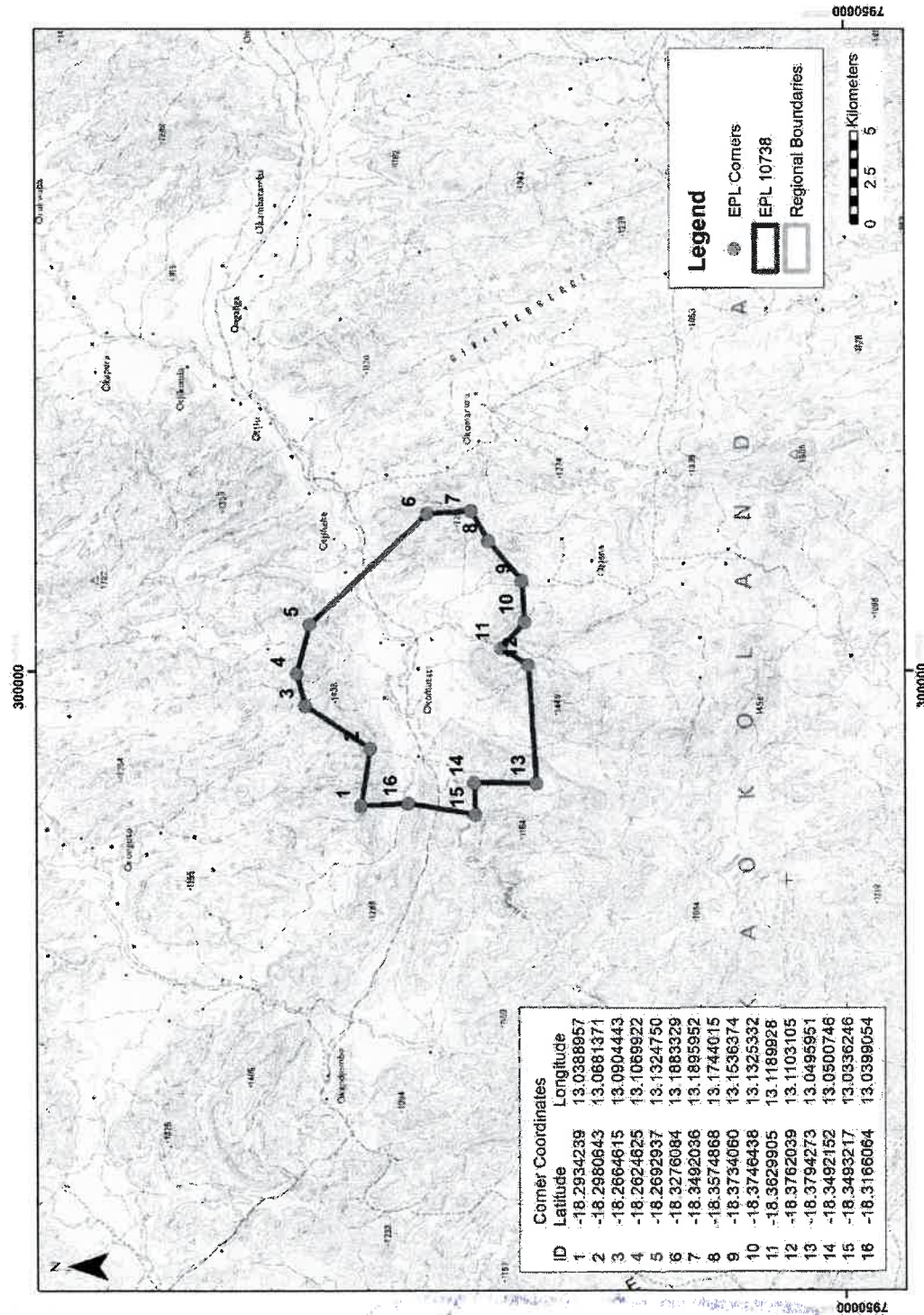
