Sinner's form gives edge in Italian player debate

CARLOS ALCARAZ said he has no doubt that top-ranked Jannik Sinner is the best player in the world on current form, as the two young players continue to lay the foundations for an epic rivalry.

Alcaraz, the 21-year-old world No 3, won the French Open and Wimbledon titles last year, splitting the four Grand Slam tournaments with 23-year-old Sinner.

The Spaniard also improved his head-to-head record with the Italian to 6-4, beating Sinner three times in as many meetings.

Sinner, meanwhile, won 73 of his 79 matches last year, including the US Open and the Australian Open, which he successfully defended at Melbourne Park last month.

"Jannik is the best right now. He has lost only four or five matches in the past year, so it's crazy. I know people say who's better out of us. They say Jannik is better, or some tell me. It is all discussion. But for me, I think for a tennis player, we have to face Jannik, and he is winning everything. He is

focused every time, so I think he's the best. Every tournament he plays, he makes the final or lifts the trophy," Alcaraz told reporters in Rotterdam on Sunday.

Alcaraz returns to action in Rotterdam after his quarterfinal loss to 24-time Grand Slam champion Novak Djokovic at the Australian Open ended his bid to become the youngest player to capture all four major titles.

"I don't feel that it was a missed opportunity against Novak. I really wanted to win the tournament and felt I was able to, but Novak played an unbelievable match. Facing Novak in the quarterfinals at a Grand Slam is the worst thing. It was a pretty good match. I've tried to take the good things about that match, and will look ahead now," added Alcaraz, who won the US Open in 2022.

Top seed Alcaraz begins his Rotterdam campaign against Dutch wild card Botić van de Zandschulp, who beat him in the second round at the US Open in August. -Supersport.com

Sizzling McIlroy captures PGA Pebble Beach title

RORY MCILROY delivered an overwhelming back-nine performance on Sunday for a two-stroke victory at the Pebble Beach Pro-Am to capture his 27th career US PGA Tour title.

The 35-year-old four-time major winner from Northern Ireland made three birdies and an eagle after the turn to fire a six-under-par 66 and finish on 21-under 267 at the famed oceanside course.

"Some people would argue that the golf courses I've won on are not up to a Pebble Beach or an Augusta or whatever, but to win at one of the cathedrals of golf is really, really cool," McIlroy said.

He added: "I knew today was going to be tough. It was going to be exciting. There were so many guys that were around the lead. And I guess with it being Pebble Beach, I had to put that to the back of my mind, and just go out there and try to shoot a score, which I was able to."

Ireland's Shane Lowry, the 2019 British Open champion, birdied 18 to shoot 68 and grab second on 269, but missed out on a fourth career PGA title.

"I didn't have my best stuff all day," Lowry said. "I just hung in there. I said let's try and make Rory win this, let's not give it to him. When players like Rory McIlroy turn up and have their A-game, they're pretty much impossible to beat. It wasn't my day, but it has been a good week," he said.

Sharing third were past US Open winners Lucas Glover and England's Justin Rose, who sank a 61-foot eagle putt from off the green at the par-5 18th to shoot 68.

Third-ranked McIlroy took only his second career triumph in California, the other coming at the 2015 WGC Match Play at Harding Park in San Francisco.

"To win in California, a place where I haven't historically played well before, it's really cool, and it's obviously a really cool way to start the season. To get this win this early, it means a great deal, and

hopefully just keep the momentum going," noted McIlroy. McIlroy has ensured an eighth consecutive season with a victory, and he hopes to complete a career grand slam at the majors by winning the Masters in April at Augusta National.

Austrian Sepp Straka, who won his third PGA title two weeks ago, led by one when the day began, but opened with a bogey, and couldn't match McIlroy's pace from there, sharing seventh on 272.

McIlroy dropped his approach to three feet and tapped in to birdie the par-5 second, then sank a 12-foot birdie putt at the par-3 seventh, but took bogey at eight after missing the green with his approach.

McIlroy sank a birdie putt from just inside 18 feet at the 10th to grab the solo lead, then made another from just inside nine feet to birdie the par-3 12th, seizing a two-stroke lead at 18-under.

"I was really proud of myself. I made that bogey on the eighth hole, and to play the next few the way I did, that gave me the cushion to make it comfortable coming down the last few," he noted.

After reaching the green in two at the par-5 14th, McIlroy had just over 26 feet for eagle, and curled in the putt to claim a four-stroke edge.

"I've hit three really good tee shots off 14. The previous two times this week, I didn't take advantage of them, and I was determined to take advantage of it today. I hit a perfect 7-iron after that drive, and to hole a putt like that across that green, it's a bit of a bonus. But that really gave me a cushion to play the last four holes," McIlroy said.

McIlroy landed his approach inside four feet at 15, and made the birdie putt to reach 21-under, then closed his round with a tap-in par at 18 after admiring the view on his walk up the iconic oceanside 18th hole.

"Really cool to have that walk up 18, and sort of take it all in. Was very cool," he said. -Supersport.com

However, when the time comes again, I will return as a coach to work on realising the team's dreams," he added.
