Nature of activity:

Paratus Telecommunications (Pty) Ltd intended to construct a base transceiver station and associated infrastructure on Erf 361 in Brakwater which lies to the north of Windhoek within the Khomas Region.

The environmental clearance certificate for the Project was issued on 19 April 2022 and is valid until 19 April 2025.

The base transceiver station's height is a height of 48 meters to provide adequate transmission and reception of telecommunication radio signals within this geographical footprint. The typical base transceiver station equipment includes 3G/4G/LTE Access Power Solutions-APS6-400 Series, High-Performance Point-to-Point Microwave Antenna, FibeAir IP-20G Radio, Panel antenna and Air Harmony 4000/4200/4400.

Scale and scope of activity:




FIGURE 1 - Location of proposed communication tower

The tower was constructed within a relatively small area (14 m²) within Erf 361 in Brakwater, as illustrated in Figure 1.

The renewal activities include continuous maintenance of the tower and associated infrastructure.
