Kamau Town Planning and Development Specialists hereby gives notice to all potentially Interested and Affected Parties (I&APs) that an application will be made to the Environmental Commissioner in terms of the Environmental Management Act (No 7 of 2007) and the Environmental Impact Assessment Regulations (GN 30 of 6 February 2012) for the following:

1. **Rezoning of Erf RE/1301, Otjomuise Extension 1 from “Residential” to “Institutional”**
2. **Consolidation of Erven RE/1003 and RE/1301 Otjomuise Extension 1, into Consolidated Erf X, Otjomuise Extension 1**
3. **Rezoning of Consolidated Erf X, Otjomuise Extension 1 from “Institutional” to “Undetermined” for Township Establishment purposes**
4. **Layout approval and Township Establishment on the Remainder of Consolidated Erf X, Otjomuise Extension 1**

In line with Regulation 21(2) of the mentioned EIA Regulations, a Background Information Document (BID) is distributed to pre-identified Interested and Affected Parties as part of the public consultation process for this EIA. 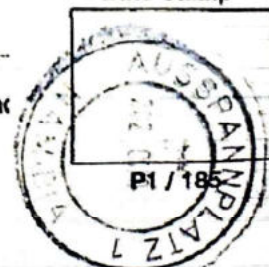

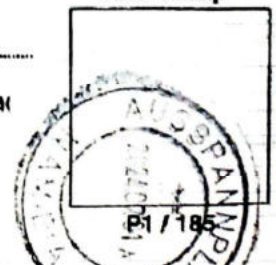

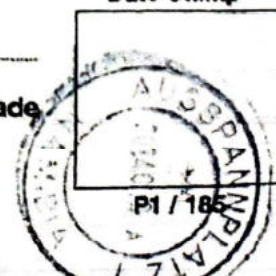
