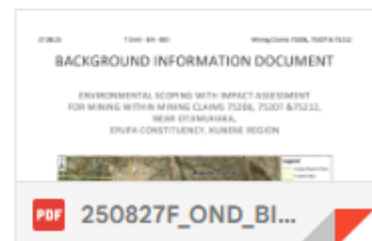
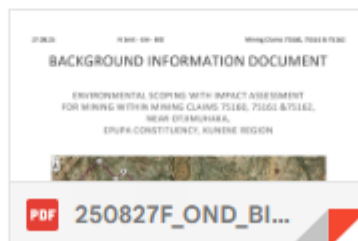
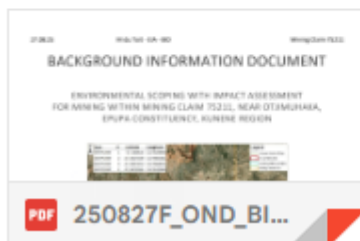

Dear Sir/Madam,

I have read the attached document and has the flowing comment:

I am currently engaged in a private research project focused on freshwater fish inhabiting the springs within the tributaries of the Kunene River. This work is being conducted with the approval of the former Ministry of Fisheries and Marine Resources, in collaboration with Ministry staff. Over the past few years, the springs of the Ondoto River and its tributaries have been sampled multiple times, revealing the presence of two rare fish species: *Kneria maydelii* and one yet-to-be-identified species. My research is ongoing, with the next field survey scheduled for December, aimed at collecting genetic data to finally confirm that the unidentified species is indeed undescribed. These findings will help determine its taxonomic classification—potentially as a new genus or even a new family. Additionally, early genetic data indicates that the *Kneria maydelii* specimens sampled may represent a distinct species within the Kneriidae family. Further sampling and analysis are essential to verify these finding

Preliminary results suggest that this specie may be endemic to the spring environment, raising concerns about the impact of nearby mining activities, particularly freshwater abstraction, on the integrity of the springs and the survival of both species. I strongly propose to conduct an EIA to establish the impact of water abstraction on the livelihoods of the springs in the Ondoto River. An Environmental Impact Assessment (EIA) is needed to evaluate how water abstraction may affect the springs and the biodiversity supported by these spring ecosystems.

Thank you for your valuable input and for sharing the preliminary research findings regarding the fish species inhabiting the Ondoto River springs. Your observations on *Kneria maydelii* and the potentially undescribed species are noted as being of high ecological significance.

Your recommendation to conduct a full EIA focusing on the potential impacts of water abstraction on the integrity of the spring systems and associated biodiversity is acknowledged. This concern will be carefully considered during the assessment process, and relevant potential specialists will be looked into to evaluate the potential ecological risks.

5.1. STAKEHOLDER ENGAGEMENT SUMMARY

During the advertised comment period, only one written submission was received via email. Apart from this, no further written comments were submitted. The majority of stakeholder input was collected during the public consultation meeting.

Summary of written submission:

Private Researcher Submission – A researcher undertaking a freshwater fish study in the Ondoto River springs reported the presence of *Kneria maydelii* and a potentially undescribed fish species. Concerns were raised about the impact of water abstraction on these rare and possibly endemic species. The researcher strongly recommended that an EIA specifically assesses the risks of water abstraction on the spring ecosystems and their biodiversity.

Key outcomes of the public consultation meeting:

- Stakeholders stated that the meeting was announced on short notice, limiting attendance and representation.
- A request was made for a follow-up meeting at Ondoto village for broader community participation.
- Concerns were raised regarding unresolved impacts from GECKO's past mining operations, including environmental degradation and lack of proper consultation.
- The consultant clarified that the current EIA relates only to the new mining claims by **Morné du Toit, Timo Smit**, and **Nina Smit**, separate from GECKO's past operations.
- Community members agreed to prepare a written submission of grievances and nominate two contact people for ongoing communication. However, no submission was received at the time of drafting this report. It is recommended that, once received, the comments be submitted to the Department of Environmental Affairs (DEA) as addendum to the initial submission.

While written inputs were limited, the PPP process provided valuable insights through both email submissions and in-person consultation. All inputs will be incorporated into the Scoping Report and Environmental Management Plan (EMP).
