WE INTEND TO START MINING AS SOON AS POSSIBLE UPON GRANTING OF THE MINING LICENCES (MINING CLAIMS) BY THE MME. THE MINING ACTIVITIES WILL BE UNDERTAKEN BY US USING A LOW-LEVEL EQUIPMENT/ TOOLS. THIS WILL REQUIRE MILD SOIL EXCAVATION ALONG THE TARGETED ORE HOSTING VEINS / ROCKS. THE APPLICANT PLANS TO CONTINUOUSLY DO BACKFILLING TO PREVENT CREATION OF HUGE PILES OF WASTE ROCKS.
