### TOWNSHIP ESTABLISHMENT AND LAYOUT APPROVAL FOR UUPINDI EXTENION 2

- 1. Subdivision of the Remainder of the Farm Oshakati Town and Townlands
  No. 880 into Portion B and Remainder;
- 2. Rezoning of the Remainder of Erf 1574, Oshakati from "Informal Residential" to "Undetermined" for township establishment purposes;
- 3. Alteration of the Township Boundaries of the Oshakati Township to include Portion B of the Remainder of the Farm Oshakati Town and Townlands No.880;
- 4. Consolidation of newly incorporated Portion B with the Remainder of Erf 1574, Oshakati into Consolidated Erf X, Oshakati;
- Layout approval and township establishment on Consolidated Erf X,
   Oshakati to become known as Uupindi Extension 2;
- 6. Inclusion of Uupindi Extension 2 in the next Zoning Scheme to be prepared for Oshakati.

### TOWNSHIP ESTABLISHMENT AND LAYOUT APPROVAL FOR UUPINDI EXTENION 3

- 1. Subdivision of the Remainder of Farm Oshakati Town and Townlands No. 880 into Portion A and the Remainder;
- 2. Rezoning of the Remainder of Erf 1379, Oshakati Extension 1 from "Informal Residential" to "Undetermined";
- 3. Rezoning of Erf 5166, Oshakati Extension 1 from "Informal Residential" to "Undetermined";
- 4. Alteration of Townships Boundaries of Oshakati Extension 1 to include Portion A
- 5. Consolidation of the Remainder of Erf 1379, Oshakati Extension 1 and Erf 5166, Oshakati Extension 1 with Portion A/880 into "Consolidated Erf X";

- 6. Layout Approval and Township Establishment on Consolidated Erf X to become known as Uupindi Extension 3; and
- 7. Inclusion of Uupindi Extension 3 in the next Zoning Scheme to be prepared for Oshakati.

In line with Regulation 21(2) of the mentioned EIA Regulations, a Background Information Document (BID) is distributed to pre-identified Interested and Affected Parties as part of the public consultation process for this EIA.
