The Environmental and Social Impact Assessment (ESIA) and the reason that the Proponent appointed Excel Dynamic Solutions (Pty) Ltd (EDS), an independent Environmental Consultant to carry out the ESIA and apply for the Environmental Clearance Certificate (ECC).

## **2.2 Explanation of what an ESIA is, its Process, and the Public Role in the Process**

Mr. Silas David explained to the attendee the purpose of the meeting and why they were invited (with reference to the Environmental Management Act (EMA) No. 7 of 2007 and its 2012 Environmental Impact Assessment (EIA) Regulations on Public Consultation). Mr. David further explained that the proposed activities are one of the listed activities in the 2012 EIA Regulations of the EMA that cannot be undertaken without an ECC from the Environmental Commissioner.

## **2.3 Presentation of Potential Project Impacts**

To ensure transparency and that the attendees understand both sides of the proposed project activities, the Environmental Consultant also presented the potential pre-identified potential positive & negative environmental and social impacts.

## **2.4 Public Open Discussion (Interactive Session)**

Mr. David allowed the meeting attendee to raise their concerns, issues, and/or comments on the proposed project activities. The concerns/issues and comments recorded are presented in **Table 1** below.

1.	<p><b>Commenter:</b> When farms are locked during the prospecting and exploration phase, how will the Proponent go about with the project?</p> <p>We have issues where Proponents do not consult the farmers. Once the Proponent have obtained an ECC, some Proponents trespass farms. This causes poaching to occur within the area, and sometimes field fires which they do not mitigate.</p> <p>Many farmers object projects of this nature due to the way things are done by some Proponents. They create trenches and leave pits and trenches not rehabilitated.</p>	<p><b>Consultant (EDS):</b> The Proponent will need to get into an agreement with the farmers to ensure that both parties reach an agreement to allow access.</p> <p>Noted.</p> <p>Noted.</p>
