2.1 Title of Activity

Operation of Mining Activities on Mining License (ML) No. 222 located in the Karibib District, Erongo Region

2.2 Location of Activity

The ML is located about 13km Southwest of Karibib in the Erongo region.

2.3 Nature of Activity

The nature of the activity is that associated with the mining activities (methods) are divided into the following phases:

- Phase 1- Reconnaissance prospecting work: This involves detailed mapping, diamond drilling, sampling.
- Phase 2- Test-quarry: Following successful reconnaissance prospecting work, minor test-quarrying, test-processing and initial marketing activities are undertaken.
- Phase 3- Development Quarry: Extraction of test-blocks by means of diamond wire cutting, processing tests and notably marketing studies, production of tiles, slabs and finished goods.
- Phase 4- Production Quarry: Once positive results are obtained from Phases 2 and 3 and customers place larger orders, then project enters the production phase.

2.4 Scale and Scope of the Activity

The proposed activity entails detailed mining activity for economic feasible of good quality Dimension Stone (Marble) on the ML. The proposed activities are expected to last for about eleven more years.
