Furthermore, Sections 21 to 24 of the EIA Regulations require that Public Consultation is undertaken as one of the crucial components of the Environmental Assessment, which involves the pre-identification of potential Interested & Affected Parties (I&APs) or Stakeholders and ongoing registration of new I&APs and then subsequent consultation. You have therefore been identified as a potential I&AP for this proposed activity; therefore, you are receiving this communication.
