SUBJECT: UPGRADE & CONSTRUCTION OF ORANJEMUND AIRPORT ACCESS ROAD OF THE MR118 WITH BORROW PITS, ORANJEMUND TOWN, KARAS REGION

Reference is made to your correspondence on the captioned matter above.

The Namibia Civil Aviation Authority (NCAA) acknowledges receipt of the background information document and registers as an Affected Party for the Upgrade & Construction of Oranjemund Airport Access Road of the MR118 with Borrow Pits in Oranjemund Town, Karas Region, Environmental Scoping Assessment (ESA).

Pursuant to NAMCARs Part 139 following are the regulatory provisions to be considered during your assessment, including but not limited to:

1. NAMCARs and NAMCATS-AH 139.01.34 – requirements relating to safeguarding of aerodrome surroundings and the Airport Master Plan of FYOG.
2. NAMCARs and NAMCATS-AH 139.10 – requirements relating to Physical Characteristics.
3. NAMCARs and NAMCATS-AH 139.11 – requirements relating to Obstacle Restriction and Removal. FSS-AGA-FORM-032 and/or FSS-AGA-FORM-033 are the forms to be used to formally apply through the Executive Directors Office for any intended fixed and/or mobile objects or obstacles.
4. NAMCARs and NAMCATS-AH 139.12 – requirements relating to Visual Aids for Navigation.
5. NAMCARs and NAMCATS-AH 139.13 – requirements relating to Visual Aids for Denoting Obstacles.

6. NAMCARs and NAMCATS-AH 139.16 – requirements relating to Aerodrome Operational Services, Equipment & Installations.
