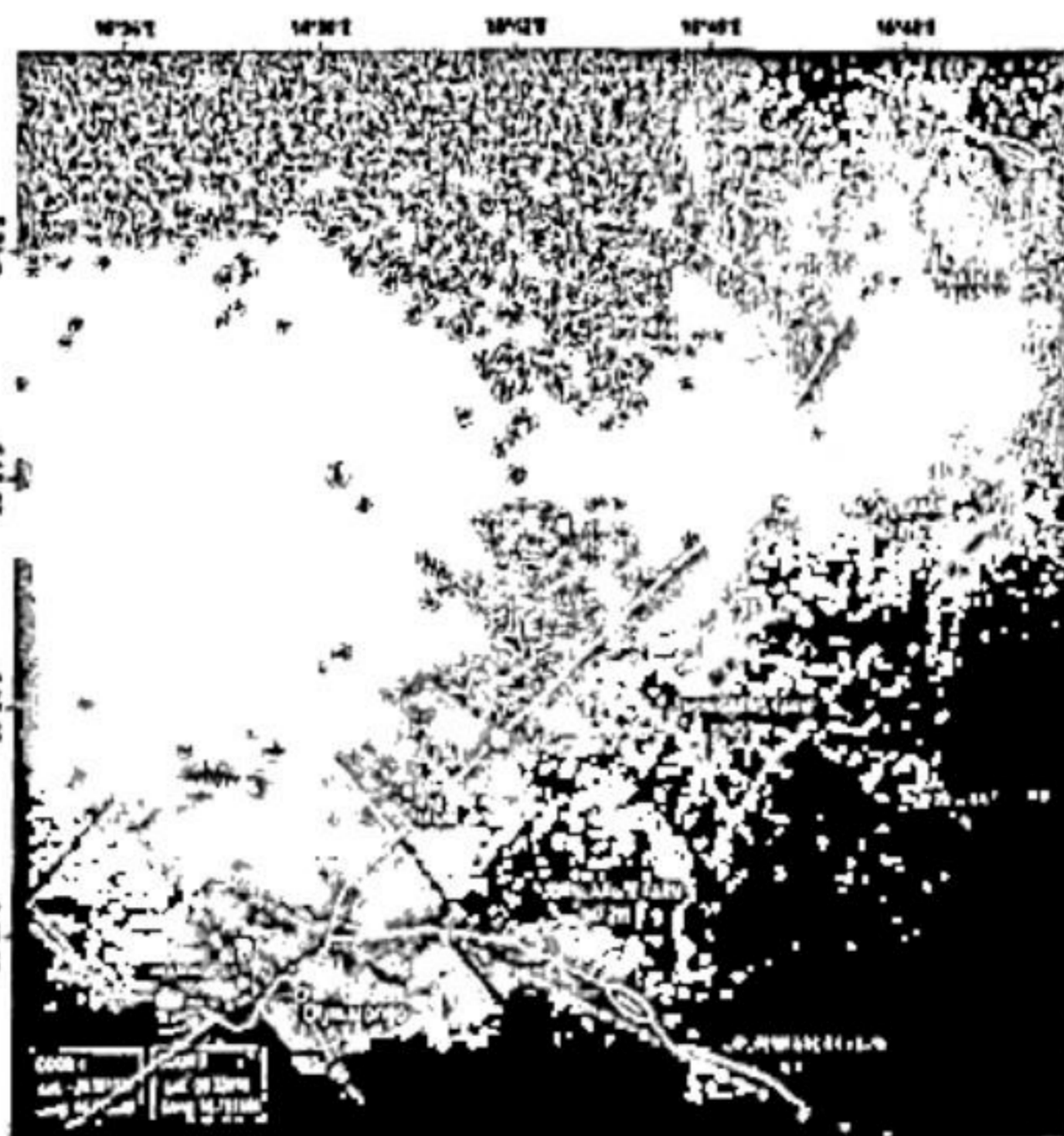

PROPOSED ELECTRIFICATION OF FARM NEVADA NO.15 UNIT 15, NEAR OTJIVARONGO

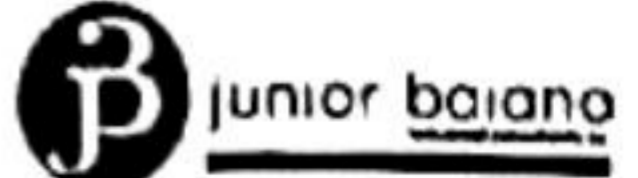
