NFA appeals for N\$10m to bolster development

THE Namibia Football Association (NFA) has made an urgent appeal for N\$10 million in financial support from State-Owned Enterprises (SOEs) to sustain football development across the country for the 2025/2026 season and beyond.

In a formal statement addressed to the Public Enterprises CEOs Forum, the NFA said football remains Namibia's most popular sport, fostering unity, youth empowerment and national pride.

However, the association highlighted ongoing financial challenges that threaten the sustainability of domestic football structures.

According to the NFA, the Premier League requires N\$20 million to operate effectively this season, yet only half that amount has been secured through government commitments.

The First Division Leagues need an additional N\$6.3 million, while

youth development programmes require about N\$1 million per region to function optimally.

"The NFA is, therefore, appealing to all State-owned enterprises to urgently consider extending financial support to Namibian football. Ideally, we seek commitments that can sustain the game for a minimum of three years, thereby allowing stability and long-term planning," the statement read.

The proposed funding will directly support youth academies and grassroots programmes, improve the management of domestic leagues and create employment opportunities for players, coaches, referees and administrators.

"We remain confident that under your leadership, the public enterprises CEOs Forum can play a pivotal role in ensuring that Namibian football thrives, not only as a sport, but also as a socio-economic driver," the statement reads.

PUBLIC CONSULTATION MEETING MINUTES:

PROJECT: Environmental Scoping Assessment (ESA) for Proposed Exploration Activities on Exclusive Prospecting License (EPL) No. 10529 located Northwest of Grootfontein in the Otjozondjupa region, Namibia.

Date: Friday, 21 November 2025

Time: 10:00

Venue: Peace Garden, Grootfontein

Six people attended the public consultation meeting, including two Environmental Consultants (Mr. Mandume Leonard and Ms. Vistolina Augustus) and one Archaeologist (Ms. Loide Shipingana) from Excel Dynamic Solutions (Pty) Ltd (EDS). Please refer to the attached attendance register for a complete list of attendees.

Supplementary farm-to-farm visits were also made . Additionally, telephone communications were used to further interact with stakeholders.

These minutes encompass feedback and discussions gathered from both the meeting and subsequent farm visits, as well as insights shared through phone conversations.

1. INTRODUCTION AND WELCOMING REMARKS

The Environmental Consultant (Mandume Leonard) began the meeting by introducing the team and explaining the purpose of the consultation, which was to engage Interested and Affected Parties (I&APs) about the proposed prospecting and exploration activities within **EPL 10529**.

An attendance register was then circulated among the attendees, enabling them to register their names and contact details, which would be used to maintain communication and provide updates on the Environmental Impact Assessment (EIA) process.

2. MEETING AGENDA AND PRESENTATION

The agenda of the meeting included the following main points:

2.1 Brief Description of the Project

Mr. Mandume Leonard provided the attendees with an overview of the EIA process, citing relevant legislations such as the Environmental Management Act and its 2012 EIA Regulations on Public Consultation. He then explained the significance of obtaining an Environmental Clearance Certificate (ECC) for the proposed project, emphasizing the attendee's crucial role in contributing to the EIA process by offering their insights and feedback regarding the potential environmental, social, and economic impacts of the proposed project.

2.2 Presentation of Potential Project Impacts

To ensure transparency and that the attendees understand both sides of the proposed project activities, the Environmental Consultant also presented the potential pre-identified potential positive & negative environmental and social impacts.

2.3 Public Open Discussion (Interactive Session)

Mr. Mandume allowed the meeting attendees to raise their concerns, issues, and/or comments on the proposed project activities. The concerns/issues and comments recorded are presented in Table 1 below.

The access agreement will outline the procedures for managing the movement of personnel, machinery, and blasting activities within the farm area, thereby mitigating potential risks to safety. |

Is this based on previously conducted exploration activities. | ML: The proposed exploration area identified based on data available from the Ministry of Industries, Mines and Energy. | 4. | What steps will be taken to protect against trespassing and unauthorized access to our farms during the proposed exploration phase? | ML: Prior to the commencement of any exploration activities on your farms, it is crucial that a mutually agreed upon the land access agreement is reached between the Proponent and the landowners. This agreement will include regulations regarding the timing of the exploration activities, ensuring that they are conducted in a manner that minimizes disruptions to farming and other land uses. |
| 5. | Since the project will be impacting the farms for an extended period of three years, what compensation measures is the proponent willing to offer to the affected farmers? | ML: Obtaining the Environmental Compliance Certificate (ECC) does not automatically give the proponent access to the farms. Instead, the proponent will need to enter into a land access agreement with the farmers before any exploration activities can commence. This agreement will outline the terms and conditions for access to the farms, including any compensation or mitigation measures for the impacts of the project on the farms. It is essential that the agreement is signed by all affected parties before any work begins, to ensure that everyone's rights and interests are protected. |
| 6. | How can we determine the standard terms and conditions in an EPL agreement, and what provisions might be considered unusual or unacceptable? | ML: The Ministry of Industries, Mines and Energy provides a standard EPL agreement template that outlines common provisions or alternatively you can seek assistance from the Office of Ancillary Rights within the Ministry of Industries, Mines and Energy. This office acts as a mediator, facilitating discussions between the Proponent and |

Land owners are also entitled to seek legal representation during the access agreement negotiations. It is within your rights to have a lawyer present to ensure that your interests are represented and to provide guidance and support throughout the process. The Minerals Act and general legal principles support the use of legal representation in negotiation and dispute resolution. Farmers are also entitled to involve a trusted representative or third party to assist in discussions or mediation.</p> |

Once the review of the draft ESA Report and EMP is done, the documents will be finalized and submitted to the Environmental Commissioner at the Department of Environmental Affairs and Forestry (DEAF) for evaluation and consideration of an ECC.
