

the parties have reached agreement as the terms being recorded in writing:

NOW THEREFORE IT IS HEREBY AGREED AS FOLLOWS:

1. LETTING

The LESSOR hereby lets to the LESSEE who hereby rents PROPERTY situated

2. DURATION

7. MAINTENANCE AND REPAIRS

The monthly rental fee in the amount of N\$ 7 000.00 must be paid to the Agent.






