With reference to our application for the Environmental Clearance Certificate (**Application No: APP-007127**) for Portion A (A Portion Of Erf No. 3785) Narraville Extension 7, Walvis Bay, we wish to clarify the matter regarding the Interested and Affected Parties (I&APs) in terms of Regulation 22 of the Environmental Management Act,2007.

The public was afforded a period of 14 days (excluding weekends and Public Holidays) to lodge objections or register as Interested and Affected Parties.

During this consultation period, no persons, organisations, or organs of state came forth to register as I&APs. The only relevant authority identified in relation to this application is the Municipality of Walvis Bay and the immediate surrounding neighbours of Erf 3785.
