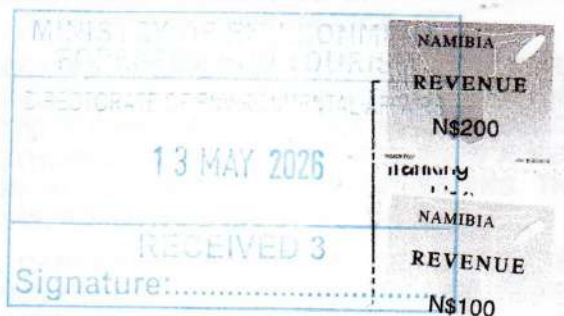

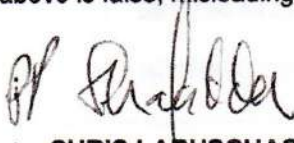
Scale and Scope of the Activity:
