ENVIRONMENTAL IMPACT ASSESSMENT (EIA) FOR PROPOSED SMALL-SCALE COPPER AND SILVER MINING ACTIVITIES IN THE KUNENE REGION

Notice is hereby given in terms of the Environmental Management Act (No. 1 of 2007) and the Environmental Impact Assessment Regulations (GN No. 36 of 2012) that an application for an Environmental Clearance Certificate (ECC) has been submitted to the Ministry of Environment, Forestry and Tourism for the following proposed development:

Project Description

The proponent (Okondjane Mining Investments CC) intends to undertake small-scale mining activities for copper, gold and silver on three mining claims located in the Kunene Region. The proposed activities will include limited site clearing, trenching, pitting, and selective ore extraction using low-impact mining methods.

Project Location

The mining claims are situated in the Kunene Region of north-western Namibia, within a remote and sparsely populated area. They are located between the local village of Ojijana and Ojijana, and lie to the east of the D705 gravel road.

In terms of regional positioning, the claims are approximately 30 Kilometres south-west of Omasas and about 63 Kilometres north-west of Swakopmund, placing them within the broader Karibiband geological domain. Access to the site is primarily via the C54 road, from which the claims are located roughly 13 Kilometres to the west of Omasas.

The three mining claims collectively cover an area of approximately 56 hectares.

Project Nature and Location: The construction of a 25m high lattice (Pine standing) telecommunication tower on ERP Site of Boldenson 4 in Rukunwuru Town, Kauundo West Region (also known as Boldenson 4). The proposed site is near the edge of the Transvaal Mountains (TSM) coordinates: 17 48'00" S 18 04'11" E and about 1km westward of the Rukunwuru High School. The site will cover a surface area of about 1480m² (30m by 12 m), and will be used to install antennae and to subserve them.

The public is therefore invited to register as Interested and Affected Parties (IAPs) and submit comments, concerns (in writing), or request further information on the EIA Study (such as the Background Information Document (BID)).
