In this regard, our office intends to undertake the following development applications:

- 2. Rezoning the Proposed Portion A from 'Undetermined' to 'Residential 2' with a Density of 1:150.**
- 3. Rezoning of the Proposed Portion B from 'Undetermined' to 'Street'.**
- 4. Alteration of the Boundaries of Lüderitz Proper to Include Portion A and B.**
