Africa Venture Partners Projects (Pty) Ltd (The Proponent) proposes to undertake prospecting and exploration activities on **Exclusive Prospecting License (EPL) No. 10196 located approximately 23 km northeast of Okahandja, in the Otjozondjupa Region.**

Mineral prospecting and exploration is one of the listed activities that cannot be undertaken without an Environmental Clearance Certificate (ECC) as per the 2012 Environmental Impact Assessment (EIA) Regulations of the Environmental Management Act No. 7 of 2007. The Proponent, therefore, appointed Excel Dynamic Solutions (Pty) Ltd, an independent Environmental Consultants firm to conduct the required Environmental Scoping Assessment (ESA) process and apply for the ECC.

Furthermore, Sections 21 to 24 of the EIA Regulations require that Public Consultation is undertaken as one of the crucial components of the Environmental Assessment, which involves the pre-identification of potential Interested & Affected Parties (I&APs) or Stakeholders and ongoing registration of new I&APs and subsequent consultation. You have therefore been identified as a potential I&AP for this proposed activity, and the reason you are receiving this communication.

Please find the attached Background Information Document (BID) for the proposed prospecting and exploration activities.

The EPL covers multiple farms, including: Waldfriede No.50, Oviumbo No.196, Okapupa East No.49, Okarupa No.48, Otjisazu No. 53, Montrose No.52, Montrose No.203, Onganjira No.66, Otjisazu Noord No.264 and Ovitoto Reserve No.55.

We are currently finalizing the date for the stakeholder's engagement meeting which is taking place next week with the affected land owners but we are also flexible to visit your office for a brief 20 minutes meeting at your earliest convenience at your suggested date and time to discuss any concerns or questions regarding the proposed project.

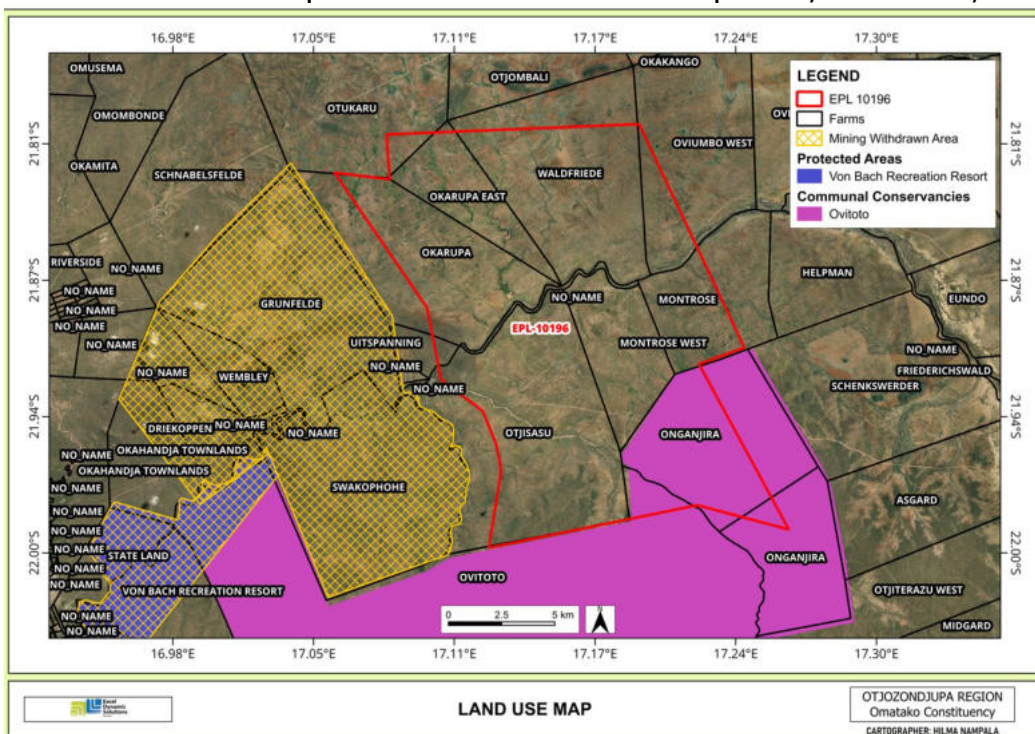
